# **ABSTRACT**

# AN INFRASTRUCTURE AND A METHODOLOGY FOR BUSINESS PROCESS MANAGEMENT

This thesis explains in detail an infrastructure and a methodology for business process management as BPM requires much more of a partnership between business and IT. With the proper methodology the business will get the strategy defined so that IT can create the best infrastructure for the situation.

The Infrastructure has been created utilizing the 5 step approach defined in the methodology explained in detail further down in the document. The Infrastructure has been includes a network of Microsoft products such as operating systems, applications and tools. The network is a fully operating small domain of servers and client machines. Once the environment was deployed and ready, an application is created using the Visual Studio .net 2003, as a sample implementation.

This infrastructre demonstrates how to implement a BPM solution to any organization using the processes defined in this thesis.

Bu döküman iş süreç yönetiminin altyapısı ve metodolojiyi detay olarak anlatıyor çünkü BPM İş ve Bilgi Teknolojileri arasındaki ortaklıktan daha fazlası gerektiren bir süreç yönetimidir. Doğru metodoloji ile İş'te belirli bir strateji uygulanırsa , Bilgi Teknolojileri o iş için en iyi altyapıyı kurabilir.

Metodolojinde anlatılan 5 adımlık yaklaşım kullanarak bu altyapı yaratıldı. Altyapı Microsoft işletim sistemleri, uygulamalar ve araçlar gibi ağ ürünleri içeriyor. Bu ağ, sunucular ve istemciler ile çalışan küçük bir domaindir. Gerekli ortam hazırlandığında, Visiul Studio 2003 kullanılarak örnek bir uygulama oluşturuldu.

Bu tez, burada anlatılan yöntemlerle, herhangi bir şirketin, bir BPM çözümünü nasıl uygulayacağını gösterir.

#### 1 OVERVIEW

#### 1.1 Introduction

A business is a collection of processes objects that represent the typical business activities performed that produce value, serve customers and generate income. Managing these processes is the key to the success of an organization. Hence "An Infrastructure and a Methodology for Business Process Management" is very important to an organization in our current world.

Unfortunately, most organizations are not set up to manage processes. Instead they manage tasks. As a result, their staff is unaware of their role in the "bigger" picture, often expending effort in the wrong areas. Waste and inefficiency creeps into the business process, leading to declining profits, productivity and competitive advantage.

For an organization to overcome this gap they will need to design their infrastructure and a methodology for BPM. This thesis will first define an architecture based on existing tools. Secondly it will talk about configuring these tools for BPM. It will also provide a manual for implementing a BPMS for a particular organization using the infrastructure. And it will have an example application of a BPMS definition using the infrastructure for demo purposes.

The methodology provided in this thesis ensures that a organizations processes have visibility and the accountability for their execution is assigned to the organizations staff, by building comprehensive process models that can be deployed in WEB ready or traditional hardcopy formats.

#### 1.2 What is Business Process Management – BPM?

Business Process Management or BPM is the practice of improving the efficiency and effectiveness of any organization by automating the organization's business processes. BPM used to be also known as Business Process Reengineering (BPR).

Many companies have business processes that are unique to its business model. Since these processes tend to evolve over time as the business reacts to market conditions, the BPM solution you choose must be easily adaptable to the new conditions and requirements and continue to be a perfect fit for the company.

In order to use BPM effectively, organizations must stop focusing exclusively on data and data management, and adopt a process-oriented approach that makes no distinction between work done by a human and a computer.

The idea of BPM is to bring processes, people and information together. Dynamic infrastructure requires separation of flows, business rules and services. Identifying the business processes is relatively easy. Breaking down the barriers between business areas, and finding owners for the processes is difficult.

BPM not only involves managing business processes within the enterprise but also involves real-time integration of the processes of a company with those of its suppliers, business partners, and customers. BPM involves looking at automation horizontally instead of vertically. Business Activity Monitoring (BAM) is essential for measurement of BPM impact.

#### 2 BPMS METHODOLOGY

# 2.1 Manual for implementing a BPMS

The Business Reengineering Methodology is a complete life cycle approach to identify and implement business process and infrastructure support redesigns for business processes of a company. It is comprehensive and complete, addressing such activities as organizing the project, assessing the current business process, designing the reengineered business process, planning the implementation and implementing the business solutions.

The methodology is divided up into five phases, comprising thirteen methodology processes, forty-two activities, and over 250 tasks. Sixteen major deliverables are defined, and over ninety outputs comprising those deliverables are outlined, and supported by over 150 examples from actual business reengineering projects. A brief overview follows:

#### 2.2 PHASE 1 – MOBILIZATION

# 2.2.1 Objectives

The major objectives in performing this phase are to lay the groundwork for managing client expectations, gain early definition of the business process under review, gain early client commitment to the business reengineering process, identify the areas of greatest need and opportunity for reengineering, address any critical issues, and begin preparing for the impact of change.

# 2.2.2 Methodology processes

The Mobilization Phase contains three methodology processes.

# **Organize Project:**

The first process, Organize Project, ensures that a clear understanding as to the project scope, objectives, deliverables, and other areas exists between the client and the project team.

# **Establish Enterprise Reengineering Program:**

The second process, Establish Enterprise Reengineering Program is used to develop an overall plan for business reengineering in the company, establishing a case for action, a governance structure for subsequent projects and partitioning the enterprise into manageable, prioritized projects.

#### **Develop Change Management Program:**

The third process, Develop Change Management Program, recognizes that the management of change is a critical factor for the successful implementation of business reengineering recommendations, and develops the change management program early in the overall project life cycle.

#### 2.2.3 Conclusion

The phase ends with a management sign-off of the overall project definition, project and plan, the enterprise reengineering plan and the change management program.

#### 2.3 PHASE 2 - BUSINESS SYSTEM EVALUATION

# 2.3.1 Objectives

This phase essentially performs almost the entire data gathering required to address the subsequent reengineering of the business processes. The four processes are not conducted sequentially, but are conducted in more of a parallel fashion.

# 2.3.2 Methodology processes

The Business System Evaluation Phase contains four methodology processes:

# **Measure Service Quality:**

The first process, Measure Service Quality, addresses customer and supplier service quality levels and their impact on the business process.

#### **Evaluate Current Processes:**

The second process, Evaluate Current Processes, looks at the business process itself, and develops the detailed documentation and analysis that forms the basis for identifying process-oriented reengineering opportunities.

# **Assess Information Technology:**

The third process, Assess Information Technology, identifies the impact on the information technology infrastructure on the business process.

#### **Assess Infrastructure:**

The fourth process, Assess Infrastructure, identifies the impact on the business process of external and internal factors ranging from the regulatory environment to business policies to organizational and human factors.

#### 2.3.3 Conclusion

The processes are brought to a conclusion simultaneously in a major milestone, the Phase 2 management review.

#### 2.4 PHASE 3 - BUSINESS SYSTEM REDESIGN

# 2.4.1 Objectives

This phase essentially performs all of the reengineering activity and produces the recommendations to establish the new business processes and effectively support them with information technology and internal infrastructure capabilities.

# 2.4.2 Methodology processes

The Business Redesign phase contains three major methodology processes:

# **Redesign Business Processes:**

The first process, Redesign Business Processes, utilizes the redesign workshops and information gathered in Phase 2 to develop change ideas, analyze change feasibility, and create the new business process.

# **Redesign Information Technology:**

The second process, Redesign Information Technology, identifies the information technology components required to support the reengineered process, and maps those requirements against the current level of IT support to identify the magnitude of IT change required.

# **Redesign Infrastructure:**

The third process, Redesign Infrastructure, maps the reengineering recommendations against the internal infrastructure (jobs, organization, policy, management systems, recognition and reward systems) to determine the recommended changes in those areas.

#### 2.4.3 Conclusion

Phase 3 concludes with an important management review in which the recommendations are reviewed for implementation approval.

#### 2.5 PHASE 4 - IMPLEMENTATION PLANNING

#### 2.5.1 Objectives

This phase essentially performs overall implementation plan with defined reengineering projects.

#### 2.5.2 Methodology processes

The Implementation Planning phase contains three methodology processes;

# **Establish Performance Requirements:**

The first process, Establish Performance Requirements, identifies the resources required to perform the new business process, and establishes the business performance objectives of the new process.

# **Plan Continuous Improvement:**

The second process, Plan Continuous Improvement, addresses the need to establish mechanisms to sustain the reengineering gains, and make additional gains.

# **Develop Implementation Plan:**

The third process, Develop Implementation Plan, addresses the cost/benefit aspect of the reengineering recommendations, defines the implementation projects, and defines an overall implementation plan.

#### 2.5.3 Conclusion

The phase concludes with an important management presentation, presenting the overall implementation plan with defined reengineering projects and anticipated benefits.

#### 2.6 PHASE 5 - IMPLEMENTATION

# 2.6.1 Objectives

This phase essentially performs the implementation of the plan that was approved from phase 3.

# 2.6.2 Methodology processes

The Implementation phase contains two methodology processes;

# **Implement Business Solution:**

The first process, Implement Business Solution, initiates, conducts and manages the implementation of the reengineering recommendations through a defined plan of implementation projects, including prototyping, piloting and roll-out.

# **Conduct Post-Implementation Review:**

The second process, Conduct Post-Implementation Review, conducts an assessment of the results of completing key projects to identify what further changes may be necessary to fully achieve targeted benefits.

#### 2.6.3 Conclusion

The phase concludes with a sign-off from the management.

#### 3 BPMS INFRASTRUCTURE

# 3.1 Architecture Based on Existing Tools

#### 3.1.1 Introduction

Business processes are dependant and ordered activities that result in predictable and repeatable outcomes. Consisting of an organization's operating procedures, institutional working knowledge, and information resources, business processes are designed to satisfy defined business objectives in an efficient and timely manner. In an efficient environment, the functional components of a process can be readily identified, adapted, and deployed to address ever-changing corporate requirements—a capability termed as business agility. By definition, business agility is an organization's systemic ability to fluidly marshal and reconfigure resources in response to business requirements and opportunities. Business Process Management (BPM) tools are designed to provide for such agility by facilitating the creation and execution of highly transparent and modular process-oriented workflows that meet the operational performance standards IT organizations demand.

Automated business processes developed and executed within such an environment are characterized by the following attributes:

- Visibility of end-to-end process activities
- Process components and functionality that are exposed and self-describing
- Ability to integrate disparate information source and application functionality into a process
- Information flow and event notification that can be automated and monitored throughout a process
- Workflow participation that makes the most of desktop productivity and communication tools

- Service level agreements that can be specified, monitored, and enforced for activities in a process
- Ability to add, remove, or reconfigure any process activity or component, without disrupting the process
- Processes that can be monitored in real time or near real time
- Process designs that can accommodate any exception handling requirement
- Processes that can be easily replicated, extended, and scaled

With the support of XML and Web Services, BPM systems are transforming the way in which IT organizations are implementing and executing workflow components. XML applies structure to information, freeing it from any functional dependency on the software that operates on it. Web Services on the other hand provide the framework for application-to-application messaging and invocation over an unbounded network. BPM tools provide the additional support infrastructure to harness these capabilities to create, deploy, and execute the entire scope of workflow management, enterprise application integration (EAI), and trading partner integration (TPI).

# 3.1.2 Selected Existing Tools

This thesis has selected Microsoft's tools for Business Process Management and supporting technologies facilitate the creation of processes that share the characteristics defined previously. The thesis also describes how XML and Web Services are deployed within a BPM solution to achieve unprecedented modularity and extensibility. Finally, the document illuminates the gains in development and operational productivity that BPM technology engenders, which in turn enables real-time business agility.

# 3.1.3 A New Paradigm

Just as standards-based Web servers and browsers facilitated the communication and distribution of information between people, BPM tools that employ standards-based

XML and Web Services technologies will facilitate the wide-scale proliferation of automated and distributed business processes.

A defining characteristic of BPM technology is the elevation of design and development functions from the program layer to the information (document) and transport (messaging) layer. An application is no longer an opaque data-centric procedural construct; it is a messaging event or messaging agent capable of processing the exposed declarative properties of rich (XML) documents. Workflow processes, integration scenarios, or trading partner interactions consist of an orchestrated flow of messages that are routed, transformed, and processed according to message content, formatting requirements, and business rules.

Transparency and modularity are also defining characteristics of BPM technology. Not only are documents and messages exposed, self-describing, and extensible, but so are the communicating endpoint definitions, services, business rules, transformation maps, and process execution instructions that exchange and act upon the messages and documents. A process component can be "loosely coupled" with any other component so that a modification made to one activity or component in a process does not necessitate changes to other activities or components. Each component is functionally independent of any other component.

# 3.1.4 Microsoft Technology for BPM

Business Process Management technology represents a major conceptual reorientation of the methodologies of workflow development and deployment for business processes. As with any paradigm shift, it must result in significant benefits to be justified. Substantial evidence already indicates that users of BPM technology are achieving dramatic development efficiencies, accelerated returns on their investment, and most importantly, reduced resource requirements. Although XML, Web Services, and BPM platforms impose a new conceptual model on business process development and execution, the technologies required to do so are proven Microsoft® products that have

been augmented to support this new paradigm. This section describes the core and supporting component technologies that constitute Microsoft's process development and execution suite.

**BizTalk®** Server is Microsoft's central platform for Enterprise Application Integration (EAI) and BPM and embodies the integration and automation capabilities of XML and Web Services technologies. BizTalk Server functions as a process execution engine and as a multi-transport hub for messaging and document transformations.

Visual Studio® .NET is Microsoft's flagship integrated development environment. The Orchestration Designer module found in previous versions of BizTalk Server is now an integral part of Visual Studio .NET with significantly more functionality. It is a visual development tool for building sophisticated workflows and processes that incorporate business rules, events, transactions, and exceptions and for linking these elements to implementation objects and messaging events. The assembled process generates an XML-based run-time script (BPEL) of the process that is executed in BizTalk Server.

**SQL Server** is tightly coupled with BizTalk Server and functions as its real-time data store for document tracking information and dehydrated instances of long-running processes.

Office 2003 redefines the functional concept and capabilities of Word and Excel by making XML the native file format. The applications can now behave like network clients, in the manner of a Web browser or e-mail client, but are capable of far more sophisticated and automated interactions with any source of XML information. Furthermore, in Office 2003, Microsoft also introduces InfoPath, an XML-based form application designed to address complex workflow documentation requirements. Because these applications can generate and decode XML documents with their respective schema definitions and processing instructions, they can directly engage in event-level interactions with BizTalk Server.

Active Directory® provides automated and federated authentication and authorization facilities as part of the process development and execution architecture. Its authentication and authorization capabilities facilitate sophisticated workflow processes that involve multiple participants, applications, documentation flows, and information sources. Active Directory also defines role-based participation attributes for workflow activities.

Host Integration Server and BizTalk Server Adapters facilitate integration with enterprise applications, legacy networking and transport protocols, and numerous data formats.

Microsoft Operations Manager and Application Center provide data center class system tools for building, monitoring, and scaling high-performance, mission-critical deployments of BizTalk Server and its supporting technologies.

Microsoft is at the forefront of XML, Web Services, and Business Process Management development and is committed to the implementation of these enabling technologies throughout its products. Nowhere are the potential capabilities of XML and Web Services more evident and maximized than within Microsoft's integration, development, and productivity technologies. The core XML and Web Services capabilities found in the new releases of BizTalk Server, Visual Studio .NET, Visio, and Microsoft Office 2003 demonstrate a coherent vision for distributing EAI and BPA development and deployment activities, both along functional lines and among stakeholders. The details of this vision become apparent through an examination of the new features and functions of the component technologies described previously.

#### 3.1.5 BizTalk Server 2004

BizTalk Server is the central product of the Microsoft Enterprise Application Integration (EAI) and Business Process Management (BPM) toolset and embodies the

application integration and process automation capabilities of XML and Web Services technologies. BizTalk Server has two core functions:

- A process execution engine that manages the steps, applies the business logic, and invokes the supporting applications of a complex process and/or transaction set.
- A multi-transport messaging hub for transforming and routing information to and from applications and process steps.

The release of BizTalk Server 2004 represents Microsoft's third generation of BPM technology. The initial introduction of BizTalk Server 2000 demonstrated Microsoft's early leadership in defining BPM functionality and supporting XML. BizTalk Server 2002 provided feature set refinements and performance enhancements. The new version of BizTalk Server is a major upgrade that incorporates the recommendations of thousands of users. BizTalk Server 2004 offers many new features and has been reengineered to provide substantial upgrades including improved performance and monitoring of process execution, robust Visual Studio .NET integration for programmatic control, and enhanced workflow modeling capabilities.

By leveraging the application integration and process automation capabilities of BizTalk Server and Microsoft Office, Microsoft has adopted the W3C XML Schema Recommendation. XML Schema is a specification that formally defines an extensive array of data type primitives and structural components for creating XML documents; it serves as a dictionary of abstract elements, attribute entities, and organizational rules. Creating XML documents that conform to the schema delivers a significant advantage: the meaning, function, and application of the document's content is comprehensible to, and operable by, any XML-enabled application that can access the document's underlying schema.

Every industry-specific initiative to develop a common vocabulary and set of procedures for the exchange and processing of information is based on XML Schema. By using XML Schema internally, BizTalk Server can import any XML schema

definition natively without translation. This significantly reduces the time and effort required to facilitate sophisticated, interactive business scenarios—particularly those that involve the exchange of multiple document types. For example, consider the emergence of generic business-to-business (B2B) framework specifications for standardizing document content and data exchange procedures and behavior. There are typically hundreds of document types and exchange scenarios identified in each initiative specification, all of which are defined using XML Schema. By supporting XML Schema natively, the BizTalk Server messaging infrastructure and process execution engine can effectively support any B2B framework initiative.

#### 3.1.6 Office 2003

XML Schema also figures prominently in the release of Microsoft Office 2003 as Word and Excel adopt XML as a native document format using an XML schema definition file. Also in Office 2003, Microsoft introduces InfoPath™, an XML-based form tool designed to propagate automated workflow capabilities throughout an organization. InfoPath allows workflow participants who create new information or perform analytical or content collection functions to generate, interact with, and exchange structured information. Typically, these activities are paper-bound or use a digital representation of paper. A form created in a word processing or spreadsheet program can be filled out easily enough, but the information that is entered in the form cannot be understood or processed without programmatic or manual intervention. Generating, conveying, extracting, manipulating, and reorganizing unstructured information in and from these formats is extremely labor intensive, inefficient, and costly.

InfoPath addresses this problem by creating smart forms that generate structured XML information, including processing instruction metadata. Underlying an InfoPath form is a template that incorporates one or more XML schemas, XSLT style sheets, embedded controls, and business logic instruction sets. The template controls the behavior of a form in the following ways:

• Generates multiple form views of the same information

- Constrains data types and values that can be entered in a form
- Defines and controls the dependencies for entering information
- Generates automatic, derived, and computed values
- Invokes events, prompts, and instructions based on dependencies
- Provides access to remote information sources
- Enables the incorporation of digital signatures

Form templates are created in a WYSIWYG design tool and require no procedural programming, predefined XML schemas, or XSLT style sheets. The schema and processing instructions are implicitly defined as the form template, which is represented in XML, is constructed from a palette of drag-and-drop controls, wizards, and dialog boxes. When an InfoPath form is populated, it generates an XML document that contains the entered and derived information, required metadata, processing instructions, and digital signatures of the participants who have accessed the form. The document also includes references to the template schemas and XSLT files required by other XML-enabled applications.

By enabling Microsoft Office applications to automatically recognize and process the information and metadata contained in a document, they become capable of engaging in event-level interactions. These "content-responsive" applications have the ability to facilitate automated workflow processes that take place between applications, and between applications and participants. This is the same fundamental premise of Web Services, and it redefines the functional concept and capabilities of these applications. They now behave as network clients, in the manner of a Web browser or e-mail client, but are capable of engaging in sophisticated and automated interactions with any source of XML information. Participants using these tools still engage in their workflow functions, but much more efficiently because of the elimination of manual processing tasks that are irrelevant to the effective execution of those functions.

# 3.1.7 Exchanging Information

BizTalk Server provides extensive transport and messaging services such as receive and send locations, adapters, pipelines and publish and subscribe distribution capabilities through a message box data store-all of which support content-based routing and processing. These facilities combined with the BizTalk Server document tracking and process monitoring capabilities, provide an overlay infrastructure for managing workflow processes. With BizTalk Server as the messaging and process hub and Office 2003 applications as XML-processing clients, participant involvement in workflows can be orchestrated, monitored, and qualified for reliability and performance metrics. This has the potential to radically alter the dynamics and efficiencies of workflow processing on an enterprise-wide basis.

The methodologies and technologies of process design, implementation, and execution are also undergoing a paradigm shift. As such, Microsoft is introducing key innovations in its BPM tools that will significantly improve process development and deployment. One of these innovations is the introduction of a set of high-level process-design and implementation tools that correspond to the roles of the participants involved in process development. These tools make it possible to graphically construct the business logic model of a process, link the steps in the model to actual implementation agents and components, and then generate an executable run-time instruction set of the finished process model in XML.

# 3.1.8 Bringing the pieces together

In the workspace, Visual Studio .NET reconstitutes the diagrammatic representation of the business process. In addition to the primitive element design palette found in Visio, it also contains a palette of implementation objects: application integration components, COM objects, Web Services, XML documents, messaging and transport facilities, and transformations. These objects are visually "bound" to the design objects through messaging events or method calls using drop, drag, and connect activities. Furthermore, the implementation mechanisms for highly complex functions, such as transactions

requiring two-phase commit, rollback, and so on, are built-in functions— thus eliminating the need to write complicated procedural code.

Because the primary dynamic of BPM exchanges is based on sending, receiving, inspecting, and transforming exposed XML documents, a BPM development tool should be capable of visually mapping the flow and exchange of information in a messaging event associated with a process step. This is facilitated through a special "Data" template that graphically represents the message flow in a process as well as the transformation of, and operations performed on, document elements through the process flow.

This assembly approach to building process applications incorporates the modular, loosely coupled, and exposed paradigm for creating any type of interaction or event. Each implementation binding or messaging event is functionally independent of any other binding or messaging event. A change on the design side does not affect the operation, function, structure, or integrity of the objects on the implementation side. In conventional process development, a complex integration or process scenario is embodied in opaque programming code. That code incorporates the structure of the endpoint objects, the process flow logic, the conversion of data formats, business rules, and the bindings to transport infrastructure. If a modification is required to any one facet of the integration module, the integrity of the entire exchange implementation is compromised. The risk of introducing unexpected behavior when modifying code has always been a pitfall of software development and it accounts for the hesitancy to make ongoing process changes in response to business requirements.

It is no accident that the tools and methodologies for developing business processes exemplify the modular, loosely coupled, and exposed paradigm that characterizes the processes themselves. This paradigm is fundamental to every aspect of the Microsoft BPM environment. The ability to visualize and comprehend complex business logic and its implementation mechanisms makes process development and maintenance

infinitely more efficient and manageable—enabling organizations to flexibly adapt to new business requirements and opportunities.

# 3.1.9 Understanding BPEL

Real-world business processes are complex and incorporate numerous integrity controls: ACID transaction support, stateful persistence of long-running interactions, nested and parallel operations, compensation and exception mechanisms, acknowledgements, and correlation capabilities. As process complexity increases, the value of being able to design, implement, and document highly dependant and sophisticated behavior using a visual assembly methodology becomes more apparent. This is especially the case when processes require modification or one process design serves as the basis for another.

The Business Process Execution Language for Web Services (BPEL4WS or BPEL) is another key standard supported by Microsoft in BizTalk Server 2004. Developed collaboratively by Microsoft, IBM, and BEA Systems, BPEL was designed to orchestrate and coordinate Web Services so they can be engaged in collaborative and transactional behavior. The BPEL specification has been submitted to the OASIS standards body for review and eventual designation as a protocol standard.

While Web Services provide the methodology for application-to-application messaging and method invocation over an unbounded network, by themselves they cannot satisfy the operational requirements of a business process. A business processes is a set of dependant and ordered activities, the execution of which results in a predictable and repeatable outcome in a timely manner. BPEL will enable Web Services to ultimately meet these requirements. BPEL formally defines basic and structured activities that are used to compose sophisticated business processes. Because a BPEL instruction set is an XML representation of a process with a precise language and grammar structure, it provides a readable and understandable instruction set for documenting a process. In fact, the object primitives used in BizTalk Server Orchestration Designer are direct

representations of basic and structured BPEL elements such as receive, invoke, sequence, flow, switch, partners, role, link, and source.

#### 3.1.10 Business Rules in Business Processes

Business processes are driven by business rules, and the majority of modifications to a business process life cycle pertain to changes in business rules (as opposed to technology-related modifications). However, because business rules in conventional applications are embodied in opaque programming code, they cannot be accessed or modified easily and without potential disruption to running processes. There's no argument that isolating business rules from procedural code or any process implementation mechanisms dramatically improves the efficiencies of managing and adapting business processes in response to new requirements or business conditions.

It is therefore of particular significance that, in BizTalk Server 2004, Microsoft introduces the Business Rules Composer. The Business Rules Composer consists of a business rule editor and engine for creating and processing sophisticated rule sets using a forward-chaining inference model. A rule set (or "Policy") that drives a specific activity or function is created with the Business Rules Composer and becomes a resource object that is referenced in a BizTalk Server orchestration. Transparency and loose coupling governs the creation and implementation of business rules. A rule set incorporated within a BizTalk Server orchestration can be viewed, modified, or replaced both at design and run time, without affecting any other operational aspect of a process or interrupting running instances of the affected process.

Isolating, exposing, and publishing business rule sets as services that can be accessed by any application or process provides one of the most compelling value propositions for the Services Oriented Architecture paradigm. As such, the Business Rules Composer module is one of Microsoft's most noteworthy products.

#### 3.1.11 BPM and the Service Oriented Architecture

The next era of computing will be characterized by the detachment of information from applications, leading to a widely distributed Service Oriented Architecture.

- The meaning, function, relationships, and presentation of information will be selfdescribing and embedded in the information itself, using schema vocabularies and style sheet references.
- Information will be generated and published without knowledge of how it will be consumed or used.
- Applications will be capable of consuming information and the methods of other applications, while being consumed themselves.
- Processes will be self-configurable and self-modifying based on event-level interactions between rule sets and information.
- Entirely new applications and business models will evolve from this paradigm.

Microsoft's BPM tools and the XML technologies on which they are built introduce the next era of computing based on the Services Oriented Architecture paradigm. In examining the innovations being introduced in Microsoft's BPM toolset, it becomes apparent how cumulative XML functionality accrues: XML Schema enables Web Services and InfoPath. XML technologies embedded in BizTalk Server enable an entirely new model for application integration and process management. Each manifestation by itself has significant value, but combined, they offer the potential to facilitate wholesale efficiencies and innovative solutions. It is an object lesson in the whole being greater than the sum of the parts.

# 3.1.12 Operational Support for BPM Technology

It is one matter to have a vision of how things can work; it is another to actually make that vision work. The innovations engendered by XML require operational support context. On their own, they cannot be simply inserted into an organization's existing infrastructure and expected to provide functional efficiencies, or to conform to the

operational performance standards to which IT organizations are accustomed. Their value is actualized when implemented within a framework of complementary and supporting technologies that facilitate their use within an embedded infrastructure. Just as InfoPath and BizTalk Server complement each other, Microsoft's array of proven enterprise applications (SQL Server, Active Directory, Host Integration Server, Microsoft Operations Manager, and Application Center) complement and support the implementation of these applications in a real-world, mission-critical context.

SQL server provides the transaction record data store for all BizTalk Server messaging events as well as dehydrated instances of long-running processes. Because SQL Server directly supports XML, it can maintain a record of the document instance associated with each message event as well. In this capacity SQL server provides the persistence capabilities of BizTalk Server.

The BizTalk Server application integration methodology is based on converting the native file formats of legacy and packaged applications into an internal XML representation, which is then transformed according to the requirements of the integration exchange. A prerequisite of this conversion function is knowledge of the native file formats. Microsoft's Host Integration Server and other third-party adaptors provide this information to BizTalk Server in a comprehensible and usable way. Furthermore, these products provide transport gateways between supported transport facilities in BizTalk Server and the transport protocols used by legacy systems. Lastly are the requirements for system performance, availability and scalability. Any enterprise-class application must be engineered to accommodate performance metrics monitoring, operational redundancy, and scalability at a granular level. This fine grain level of performance management, failure prevention, and scalability can be achieved with the support of Microsoft Operations Manager (MOM) and Applications Center. These tools are tightly integrated with all Microsoft server products and provide the operational assurances necessary for enterprise class information processing.

# 3.2 Configuring selected tools for BPM

#### 3.2.1 Architecture Overview

- 2 BizTalk servers (APPSVR1 2) with full install of BizTalk Server 2004 except no development tools
- 1 SQL server (DBSVR1) housing all BizTalk databases
- 5 development workstations (WKS1 5) with BizTalk Server 2004 development and administration tools
- 1 Domain controller (DC1), governing the MYDOMAIN.LAB domain.

Windows Server 2003 is the operating system used on all machines in this configuration.

This example has been updated with the current technology the demo is currently running on

- 1 Machine hosting: Biztalk Server 2006, SQL and development station
  - o Windows Server 2003 is the operating system on this machine.
- 1 Machine hosting: Domain Controller governing KAMILLOCAL.COM domain, IIS, Windows SharePoint Services
  - o Windows Server 2003 is the operating system on this machine.
- 1 Machine hosting: Client applications Outlook, Infopath, IE Browser.
  - Windows XP Professional is the operating system on this machine.

#### 3.2.2 Installation Steps

Figure 3.1 shows a list of steps for installing and configuring BizTalk Server 2004 to work in the multi-server configuration. This table is adapted from the *Installation Guide.htm* file that ships with BizTalk Server 2004. The ordering of steps has been changed in some instances to aid preparation, and a few steps have been added to smooth the process. The *Server* column tells you on what machines to perform each step.

#### 3.2.3 Detailed Instructions

#### **Steps 1 – 13. Install Prerequisites:**

Follow instructions in the Installation Steps table.

**BEST PRACTICE:** in most situations, it's helpful to organize the installation files for all of the prerequisites and store them on a network drive. Figure 3.5 shows an example where the folder names are keyed to the steps in Table 3.1.

Some steps such as DTC Configuration have no installation "bits," so in that folder I store a text file with instructions for performing the step. This helps avoid confusion that steps might be missing.

## **Step 14. Create Security Accounts and Groups:**

BizTalk Server 2004 Security Accounts and Groups:

Before running the BizTalk Server 2004 Configuration Wizard, a number of security accounts and groups must be created in Microsoft® Active Directory®. The Installation Guide and BizTalk Server Help files discuss the details of this, but do so in separate pieces and appear to miss a few group memberships. Table 3.1 shows a complete list of accounts and groups that can be used for a successful install.

#### **BEST PRACTICES:**

- Create an OU called **BizTalkServer** and create all accounts and groups within that.
- Enter the *Full Name* and *Group Name* as shown in the lists below when you are creating the account. The configuration wizard will pick these up automatically... otherwise you'll have to pick the right one when it asks you for a different name.
- You don't have to enter a First Name and Last Name when creating the accounts;
   the ones shown here are just for completeness.
- Stick to the "backwards" naming of BtsInstanceHost and BtsInstanceIsoHost *Usernames* as shown.
- Do not create a new account for \* entries... use the *Username* in parentheses when prompted for the account by its *Full Name* in the configuration wizard.

# Group Notes:

- These are all Global groups and that works for this testing. But recall that only
  Domain Local groups may have Global Groups as members, so you may want to try
  different types of groups.
- The members shown in bold type are recommended by the configuration help file. I have found the other memberships to be necessary also.
- Adding the <logged on user> is easiest by adding the *Domain Users* group.
- I added *Domain Users* to *BizTalk Server Administrators* in order to allow HAT to attach orchestrations to the debugger. This could be accomplished with a more restrictive group for enhanced security... but it works for testing.

#### SQL Server 2000 Security Accounts and Groups:

For this laboratory, I also made security group for server access to database: *Domain Servers* is a Global Group containing APPSVR1 and APPSVR2 computer accounts.

Added this group as a SQL Server Login on DBSVR1, having Server Administration and db\_owner privileges on Master, msdb, model and tempdb. This didn't allow Windows SharePoint Services Central Administration to set the database server, which was the intent. Setting MYDOMAIN\Domain Servers as a member of the BUILTIN\Administrators group worked.

#### Step 15. Install BizTalk Server 2004:

Installation is pretty straightforward; it's the troubleshooting and configuration that can run into some complexity. For troubleshooting, look in these places:

- Readme.htm
- Installation Guide htm
- BizTalk Server Documentation (help file)
- The Galileo-Voyager Discussion (Technical) distribution group.

For installation in a remote development architecture:

- Perform a complete installation of BizTalk Server 2004 onto the application servers. Note that development tools will not be installed because Visual Studio .NET 2003 is not installed on the application servers. The installer will give a warning about this but allow you to proceed.
- 2. Perform a development tools-only installation of BizTalk Server 2004 onto the client workstations.

On all these installs, be sure to use the "Set…" button on the install wizard's summary screen to set your password for automatic reboot. If this button does not appear, then no reboot will be needed.

#### Step 16. Install BizTalk Server 2004 Development Tools:

Note: prerequisites listed in the Installation Steps table that are labeled "Workstation" are required on the workstations before performing this step.

#### From Installation Guide.htm:

When performing a custom installation that only includes the Development option, two computers are required. You must perform a complete installation and configuration on the first computer, create a new BizTalk Group, and then on a separate computer perform a custom installation for Development only. During the Development-only installation, join the existing BizTalk group and specify the SQL Server where your group was created.

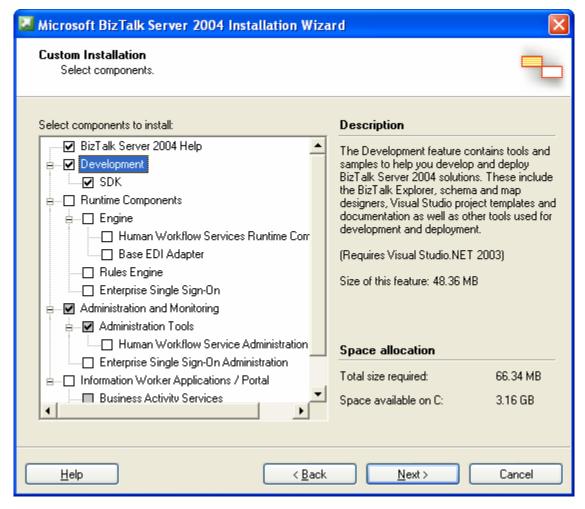


Figure 3.6 Installing BizTalk Server 2004 Development Tool-only

Run the BizTalk Server 2004 setup.exe on each development workstation. Choose Custom install, then uncheck all options except for *Development* and *SDK*. I recommend also installing *BizTalk Server 2004 Help* and *Administration Tools*, as shown in Figure 3.6.

#### From Readme.htm:

If you perform a custom installation and install Development tools only, the file bm.exe.config is not installed and the file BAMconfiguration.xml is not created. You must perform the following procedure to install the missing files.

- 1. Open the command prompt.
- 2. At the command prompt, type the following:
  - <installation directory>\Tracking
    xcopy bm.exe.config.tmpl bm.exe.config
    xcopy BAMconfiguration.xml.tmpl BAMconfiguration.xml
- 3. In the BAMconfiguration.xml file, created in the previous step, edit the tags for the following databases to point to the correct database and server:
  - a. BAMPrimaryImport
  - b. BAMArchive,
  - c. BAMStarSchema
  - d. Analysis

#### **Step 17. Configure BizTalk Server 2004:**

By default, the Configuration Wizard will run automatically after BizTalk Server 2004. If your prerequisites are not in place (especially steps 11, 12 and 14 above), you may elect not to run the configuration wizard at this time in order to finish preparation. In this case, you may then launch the configuration wizard when ready from: C:\Program Files\Microsoft BizTalk Server 2004\ConfigFramework.exe.

# **Using the Correct Security Accounts and Groups:**

When the Configuration Wizard asks you to configure which accounts and groups are to be used, it often lists its defaults without a domain qualifier. For each account and group, be sure to add the domain qualifier or configuration will fail.

#### **Using the Correct Databases:**

If you have SQL Server 2000 installed on the box on which you're installing BizTalk Server 2004, the Database Configurations screen of the Configuration Wizard will default all 13 databases onto the local SQL Server. Be sure to change them if that is not what you want.

#### **IP Address:**

The Configuration Wizard provides a choice for binding MSMQT to an IP address. Once this choice has been configured, a complete unconfiguration and re-configuration will be necessary to change it. In most cases, it is fine to accept the default to bind to all IP addresses on the box.

If you are load balancing your BizTalk servers, do *not* enter the virtual load-balanced address here; either leave it blank or enter the local IP address that the load-balanced address resolves to on this server.

# **Silent Configuration:**

Silent configuration is very useful when configuring several BizTalk servers. You must first perform a successful manual configuration using the Configuration Wizard. Steps:

- 1. Begin manual configuration using Configuration Wizard.
- 2. On the Summary page of the Configuration Wizard, click "Save..." to save the configuration to an XML file (defaults to ConfigXML.xml).
- 3. Finish the Configuration Wizard and ensure that it completes correctly.
- 4. Open the ConfigXML.xml, and replace each occurrence of \*\*\*Hidden\*\*\* (in the <PASSWORD> tags) with the correct password for each account.
- 5. Copy ConfigXML.xml to the next BizTalk server you wish to configure.
- 6. Run ConfigFramework.exe from the command line with the "/s" switch. Example: >configframework /s ConfigXML.xml /l config.log where /l sends the output to a log file.

Note that if you're installing BizTalk servers in a server group, you can't use the ConfigXML.xml file from the *first* configuration to silently install the *second*, because they're different configs: the first is to create the databases and the second is to join the databases. You can use ConfigXML.xml from the *second* to silently install the *third* and subsequent servers in the group.

#### **Development Tools-only Configuration:**

You must run the Configuration Wizard on workstations that have had a development tools-only installation, in order to join them to the BizTalk Server group that you wish to develop against. This is the simplest and quickest configuration: choose "Join" on the first screen of the Configuration Wizard then specify the BizTalk Server management database server on the next screen.

#### **Manual Configurations:**

After installation and configuration, you probably want to enable the MSMQT adapter. MSMQT is exposed to external servers exactly like an MSMQ private queue, and is recommended over MSMQ for BizTalk queuing. To enable, just add it as an adapter using the BizTalk Administration Console. This is a one-way operation; you can't remove it without a full reconfiguration. See "Configuring the MSMQ Transport Adapter" in BizTalk Server Documentation for full instructions.

**BEST PRACTICE:** back up the Master secret from the SSO database. If anything bad happens to the SSO database and you don't have a backup of the master secret, BizTalk Server won't work anymore, and only a full re-installation will fix it. You just need to run a single command:

ssoconfig -backupsecret <backup file>

See "Backing Up the SSO Master Secret Key" in BizTalk Server Documentation for full instructions.

## 3.2.4 Connection Tip:

You can use Windows Remote Desktop Connection to connect to servers for installation and management. To avoid issues related to installation over Terminal Server, add "/console" to the Computer name in the .rdp configuration file. Example:

Computer: APPSVR1 /console

User name: Administrator

Password: ••••••

Domain: MYDOMAIN

#### 3.2.5 Databases:

Table 3 shows a list of databases that are created (for a full install) by the Configuration Wizard when you choose "Create" new BizTalk Server group on its first screen. The Configuration Wizard allows you to specify which database server should be used for each database, but it uses defaults for other details of database creation, such as initial size and location of the data and log files.

After creation, it is wise to change settings for some databases. For instance, **BizTalkMsgBoxDb** and **BizTalkDTADb** will process most of the normal messaging traffic, so they should be sized accordingly and placed on the fastest drive(s) available on the SQL Server. Furthermore, in cases where maximum performance is required, it is helpful to place log files and data files on different drive spindles, if possible (i.e., not two partitions on the same drive).

It is possible to edit the parameters of the SQL Server model database in order to provide defaults for databases that are created, but this is not recommended. If database creation takes too long (for example, several minutes for a 10GB database and a 5GB log file), the Configuration Wizard may time out due to non-responsiveness of SQL Server. Furthermore, we don't want all the databases to start this big.

**BEST PRACTICE:** let the Configuration Wizard create the databases using typical defaults, then move and resize selected databases as appropriate using SQL Server Enterprise Manager.

If the Configuration Wizard fails for the first BizTalk server of a group, the configuration will be transactionally rolled back to uninstall any changes so far. However, the rollback does *not* include deletion of the SQL Server databases, so these need to be deleted manually before configuration is attempted again. First be sure to do a ConfigFramework.exe /u to un-configure, and then use Enterprise Manager to delete any BizTalk Server databases that were created before the configuration failure.

#### 3.2.6 Load Balancing

## **Load Balancing MSMQT:**

To load-balance MSMQT over TCP/IP, the following table shows which protocols and ports must be enabled in the load balancer.

Both transactional and non-transactional queues are expected to work in a load-balanced scenario.

## **Load Balancing File Receive:**

It seems compelling to specify a file receive folder on a remote server that can be used by more than one BizTalk Server as a file receive folder, in order to provide a simple load-balancing scenario on a file receive. However, a race condition may arise in cases of heavy load that causes some messages to be locked and orphaned. A symptom of this is "File Not Found" errors appearing in the Application Event Log as one server tries to receive files that are already being received by another server. Therefore, it is

not recommended to try to load balance file receive locations unless you have a compelling reason to make it work.

There is a workaround for the race-condition issue, and you may wish to investigate its suitability for your application. BizTalk Server 2004 is able to rename files before locking them for reception. Since the rename can be done in a single file system operation, it prevents other servers from attempting to receive them. To enable this feature, create a new registry key for all receiving servers: HKLM\System\CurrentControlSet\Services\BTSSvc{GUID}

RenameReceivedFiles DWORD 1. This has a few side effects:

- The files are renamed by being given a new extension (.BTS-WIP). This means that if there is any service interruption before reception is completed (such as dropping the SQL Server connection), these files could be orphaned because they will not be picked up under the file mask that filtes that receive location. You don't want to change the file mask to \*.\*, because this negates the effect of renaming the files. An idea for solving this is to create another receive port/receive location that is only serviced by a single BizTalk Server, and set its file mask to \*.BTS-WIP. This will pick up any files in the receive folder that are orphaned by this issue.
- During failover, the file renaming option will not operate correctly. Since failover should be a rare occurrence, you may wish to accept this risk to gain the performance of load balancing a file receive location, if that is your requirement.

#### 3.2.7 Installing MSMQ and MSMQT on a BizTalk Server

It is not recommended to install both MSMQ and MSMQT on a single machine. The best practice is to use MSMQT only for BizTalk message queuing; this is exposed to clients exactly as an MSMQ private queue.

In the case that your solution requires both queuing technologies, here are instructions for side-by-side installation of MSMQ and MSMQT on a single server.

- 1. Make sure your operating system will support side by side. Side by side is supported only on Windows Server 2003, Windows 2000 SP4, and Windows XP SP2.
- 2. You will need 2 IP addresses on every machine that will have BizTalk Server and MSMQ side by side. You can install two network adapters on these machines or add 2 static IPs on the same network interface card. If you choose the second option, both addresses must be in the same subnet. The first IP will be used by MSMQ and the second IP will be used by BizTalk Server/MSMQT.
- 3. You will need a new, unused computer name. The computer name will be used by BizTalk Server to store MSMQT configuration. If you append "MSMQT" to your computer name you will usually get an unused computer name.
- 4. For practical purposes, we will assume that your computer is called MyServer and BizTalk will use MyServerMSMQT.
- 5. Ask your network administrator to configure the DNS so that any query for MyServer will always return only IP1 and a query for MyServerMSMQT will always return only IP2. This can be achieved by disabling DNS registration on your machines and manually adding entries in the DNS tables.
- 6. Note: This is very important. If a query for MyServer will return both IP1 and IP2, messages sent to MSMQ might end up in BizTalk/MSMQT queues
- 7. Test the DNS configuration. From the command prompt, type "nslookup". Type MyServer and make sure that only IP1 is returned. Type MyServerMSMQT and make sure that only IP2 is returned.
- 8. Install MSMQ.
- Configure MSMQ for side-by-side. Using the registry editor, browse to
   HKEY\_LOCAL\_MACHINE\SOFTWARE\Microsoft\MSMQ\Parameters.
   Add a new string value called BindInterfaceIP. Set its value to IP1. Restart the
   MSMQ service.
- 10. Install BizTalk. In the configuration framework MSMQT screen, set the IP field to IP2. Set the computer name to MyServerMSMQT. If you plan to use

PUBLIC or PRIVATE format names, check the active directory box. Do not check the "register in dns" box unless advised so by the network administrator.

# Side-by-side limitations:

- Communication between MyServer and MyServerMSMQT is only possible with the PRIVATE/PUBLIC format names.
- There are no restrictions when a third party communicates with MSMQ or MSMQT.

# 3.2.9 Update to Installation Steps

Due to the update in the BizTalk installation to version 2006 the installation steps have been updated the following describes the updated steps.

- Install windows 2003 standard server to a Pentium IV 3.0 machine.
  - o Install SP1 and the other security updates.
  - o Install the DNS Server
  - Run on the command prompt, depromo command, it creates active directory forest.
  - o Make sure all the configurations on DNS Server is correct. (Check the names of the forests, check the client IP addresses, check the nameservers, ldap ports, msdcs settings.)
  - o Setup all active directory users and groups.
  - o Make sure that all the BizTalk group types must be "security" and "global".
  - O Please make sure that you use exactly the same names that we gave on our manual.
  - o Install Exchange 2003 and SP1
  - o Enable all exchange settings for all users.
- Install windows 2003 standard server for the 2<sup>nd</sup> Server for BizTalk

- o Normally SP1 should be installed onto this server in the beginning, but we had some problems with BizTalk 2006 and Office Tool, so we did not install it at the beginning, we had waited until we install all the instruments.
- o If you are working with BizTalk 2004 than install SQL 2000
- O If you are working with BizTalk 2006 than install SQL 2005 (BizTalk 2006 may work with SQL2000 but recommended database is SQL 2005.) Standard installation will be fine.
- o Install IIS 6.0 and do not forget the indexing services. Also do not forget to install ASP tools.
- o Install .NET Framework 1.1.
- o Install SharePoint Services 2.0
  - Make sure SharePoint services installation completed without msdn. For this feature you can use the command "setupsts.exe remotesql=yes" in the command prompt.
  - Configure the SharePoint services must use SQL2005 database.
  - Configure the SharePoint Services for the default website.
  - Make sure you can browse SharePoint services web page.
- o Install Office 2003 and InfoPath.
  - Do not forget to install InfoPath after we had installed
     SP1 we had difficulties to install InfoPath or other office tools.
- o Install Visual Studio without SQL Desktop Edition.
- Now, install Biztalk2006. It downloads some components from the internet so be sure that you have connected to internet with a stable internet connection.
  - If we compare with Biztalk2004 it is simple, mostly you click the next button and follow the instructions. But of course you have to configure and be careful with many settings.

- After installation, it will automatically run configuration table.
  - You can't skip any configuration, you have to follow it step by step.
  - Make sure you match the correct, user names, group names (it will automatically create the users on the local machine, but we need to use domain users and groups), database name and server name.
  - Important tip! At the middle of the configuration, export the file named "config" and save it to your hard drive, in case of any problem you can use it easily.
- After the configuration check the SQL Server database, to see if the expecting databases has been appeared.

#### Important Tip!

- On the SQL Server Regional Settings must be United States. Because when you are installing SQL Server it looks at your regional settings and if it is for instance, Turkey, it installs with Turkish Character support settings and you keep on working until you have problem on BizTalk server configuration. You have to format your PC or server and install all from the beginning of course do not forget to change your Regional Settings to US.
- Another important tip is, if your SQL server and your BizTalk Server are installed on different PCs, you may have MSDTC problem. It means that you are facing with a connection problem with two systems. Normally they say you can change it from component setting at MSDTC and Security Configuration or from the registry. But we could not succeed in most of the case. So if you face with the same problem, and if you can not solve it, just leave it and install them on the same server.

#### Client Configuration:

o Install windows XP Pro on a computer install SP2 and all security settings updates. Join this computer to active directory. Log on

this computer as an administrator, install office 2003 including infopath, visual studio, setup all the outlook settings.

# 3.3.1 Methodology - An example application of a BPMS definition using the defined infrastructure

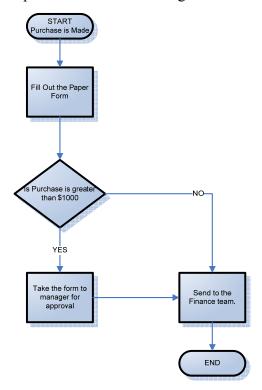
Utilizing the methodology described above the Tower Organizations Purchase Order Process has been identified to be analyzed and automated.

#### **Phase 1: Mobilization**

It is understood that Tower Organization would like to minimize cost by automating the purchase order process in the organization. By automating the process the organization will reduce man hours spent on this process.

#### **Phase 2: Business System Evaluation**

The finance team is interviewed and the AS-IS environment is created. The below diagram shows the current process in the Tower Organization.

#### **Phase 3: Business Systems Redesign**

The AS-IS environment is analyzed and the TO-BE environment is created. The below diagram displays the Purchase Order to-be process for the Tower Organization.

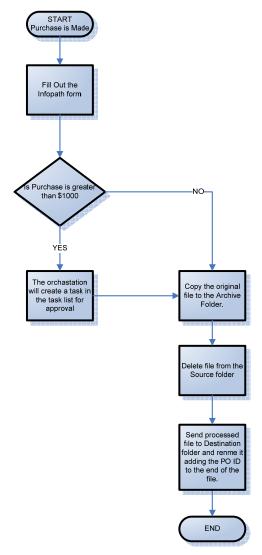


Figure 3.8 Purchase Order to-be Process

## **Phase 4: Implementation Planning**

It is understood that Tower Organization would like to have the application available 24-7 and centrally available to all users via a web browser.

## **Phase 5: Implementation**

The Microsoft solution is selected because over the last two years, based on thousands of successful deployments, BizTalk Server has clearly demonstrated that a platform

based on XML technologies can dramatically improve the efficiencies and economics of application integration development. With the innovations introduced in BizTalk Server 2004, Office 2003, Visio, and Visual Studio .NET XML technologies will demonstrate an even greater potential to deliver operational efficiencies and benefits—and will, no doubt, assume a prominent role in enterprise computing.

And also Tower Organization currently has a Windows based network which makes the integration process less costly, painless and quick.

# 3.3.2 Infrastructure - An example application of a BPMS definition using the defined infrastructure

The following example displays how to configure BizTalk Server 2006 to send and receive messages using the Windows SharePoint Services adapter and Content Based Routing (CBR), incorporating integration with Microsoft Office, and finally how to access the Windows SharePoint Services context properties of an incoming message at run time and then determine the destination of that message based on a property using dynamic ports in an orchestration.

This example assumes that Tower Holding is the organization who requires a Purchase Order automation application.

#### 3.3.3 Prerequisites

The example utilizes a single server deployment with a complete installation of BizTalk Server 2006 running on Windows Server 2003. The environment also includes the following applications running on Windows 2003;

- 1. WSS (Windows SharePoint Services)
- 2. WSS Connector for BizTalk Server 2006
- 3. Visual Studio 2005
- 4. SQL Server 2005

This example utilizes the latest technology that was provided by Microsoft.

**Note:** Initially this thesis started using the BizTalk 2004 technology. Due to a late release by Microsoft this thesis adopted the new BizTalk 2006 server and the code of the example has been converted from the BizTalk 2004 version to the new BizTalk 2006 for it to proper in the latest technology.

#### 3.3.4 Steps for Creating the Example

## Create a BizTalk Project:

In this procedure an empty BizTalk Project and a schema is created using the BizTalk Editor.

## Create a strong name key file:

- 1. Click **Start**, **Programs**, **Visual Studio 2005**, **Visual Studio Tools**, and then click **Visual Studio Command Prompt**, shown at figure 3.5.
- 2. Type *sn -k C:\KamilTez\tower.snk*, and then press **Enter**. The key pair will be written.

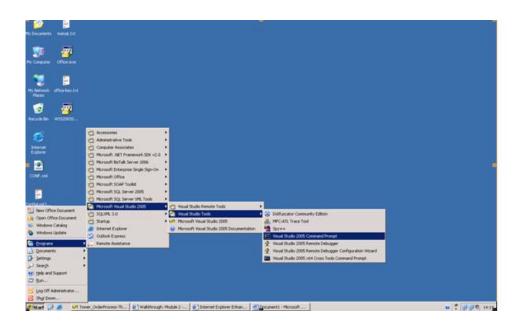


Figure 3.9 Creating the Strong Name Key File

#### Create an Empty BizTalk Project:

- Click Start, Programs, Microsoft Visual Studio 2005, and then click Microsoft Visual Studio 2005.
- Click File, New, and then click Project. Under Project types, select BizTalk Projects. Under Templates, select Empty BizTalk Server Project.
- 3. Type "Tower OrderProcess-Thesis" in the Name field.
- 4. Type C:\KamilTez as the working directory in the Location field.
- 5. Click **OK**. The screenshot below displays the create a new project screen in Visual Studio 2005.

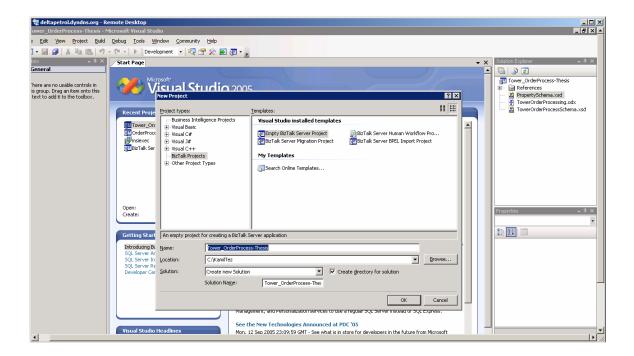


Figure 3.10 Create an Empty Biztalk Project

#### Associate the key file with the assembly

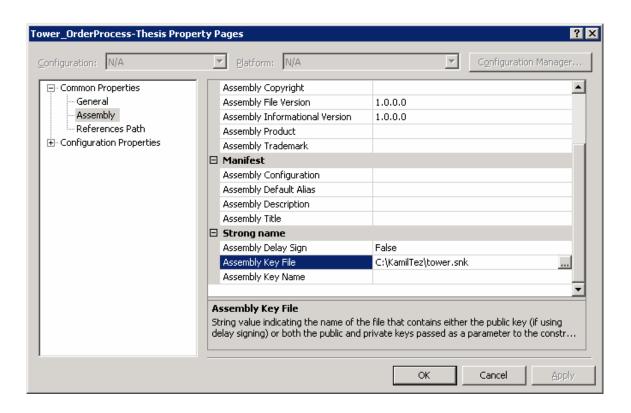


Figure 3.11 Associating the key file with assembly

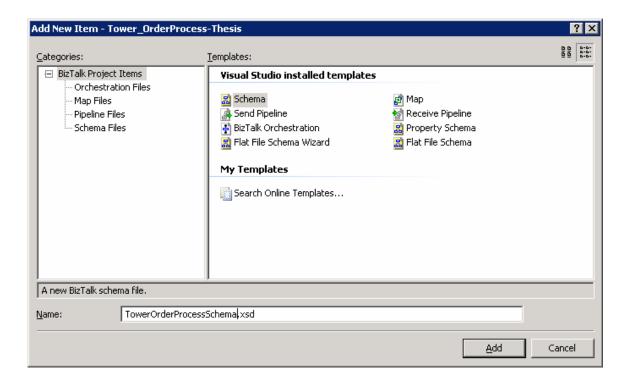


Figure 3.12 Create an XSD Schema

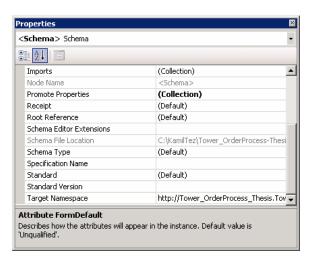


Figure 3.13 Target Namespace

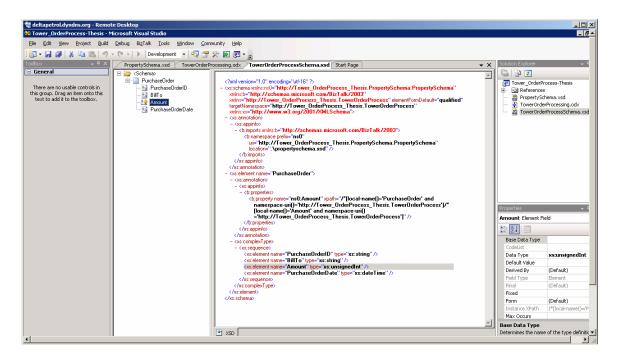
Figure 3.15 XSD TowerOrderProcess-2

# **Configure Windows SharePoint Services**

In this procedure we will create a SharePoint top-level Web site that contains three document libraries. The Windows SharePoint Services Adapter uses these libraries to move a message from a source library to a destination library. This message is also archived in a document library.

Create a Windows SharePoint Services Site:

- 1. Click Start, Programs, Administrative Tools, and then click SharePoint Central Administration.
- 2. Under Virtual Server Configuration, click Create a top-level Web site.

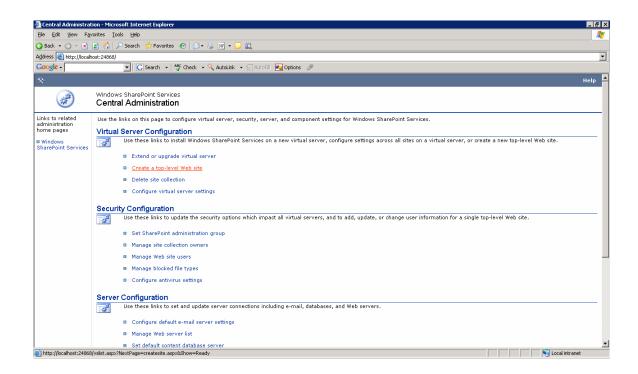


Figure 3.17 Sharepoint Server Site 1

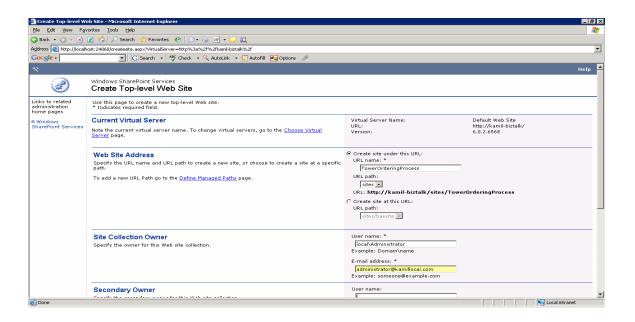


Figure 3.3.18 Sharepoint Server Site 2

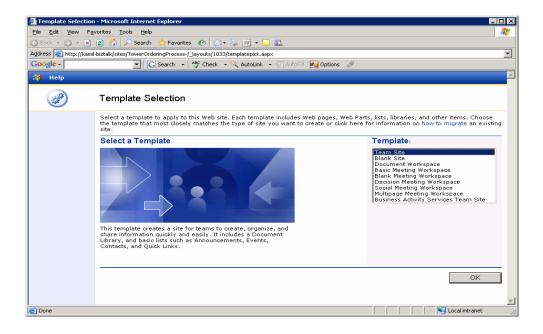


Figure 3.19 Team Web site

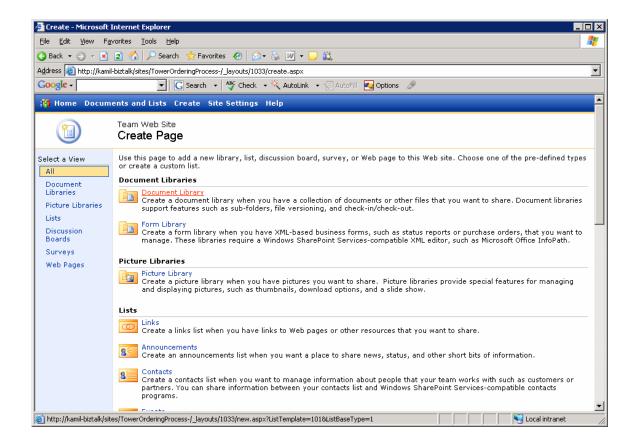
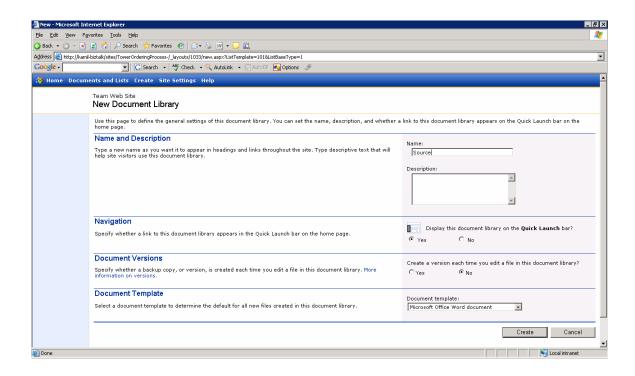


Figure 3.20 Team Web site 2

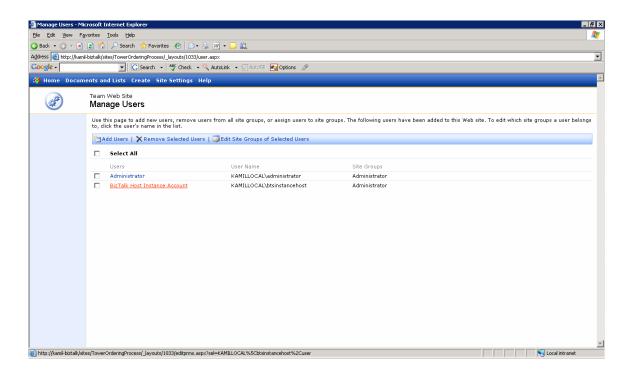


Figure 3.22 Configuring SharePoint Security

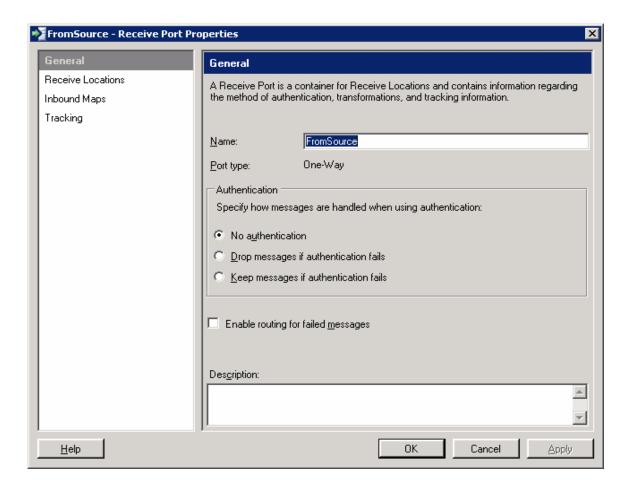

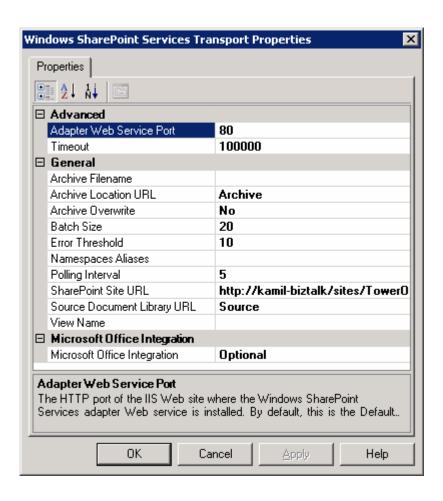


**Figure 3.23 Creating Receive Ports**

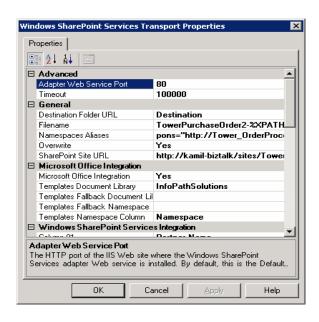


Figure 3.25 Send Port Properties window

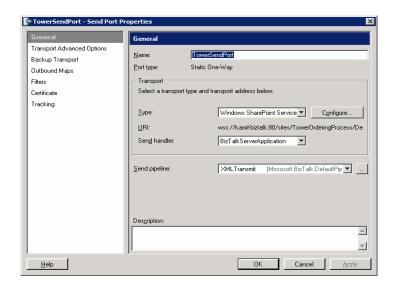


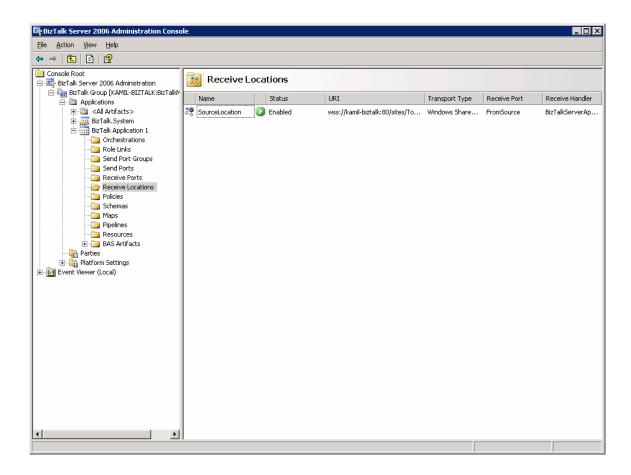
Figure 3.26 Pipeline Drop-Down list, XML Transmit.

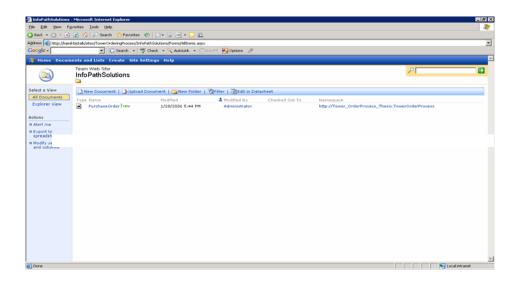


Figure 3.28 Creating new Document Library

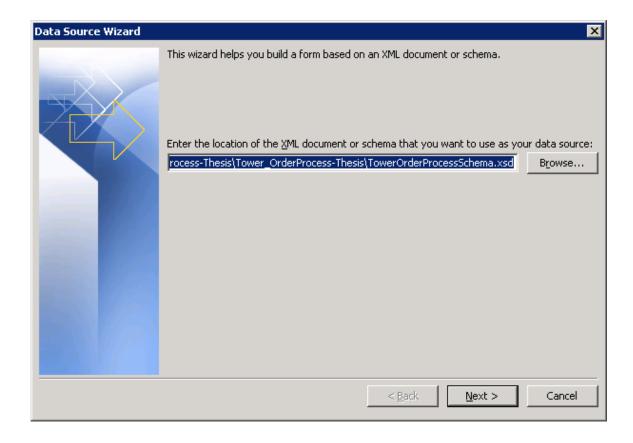


Figure 3.29 Data Source Wizard

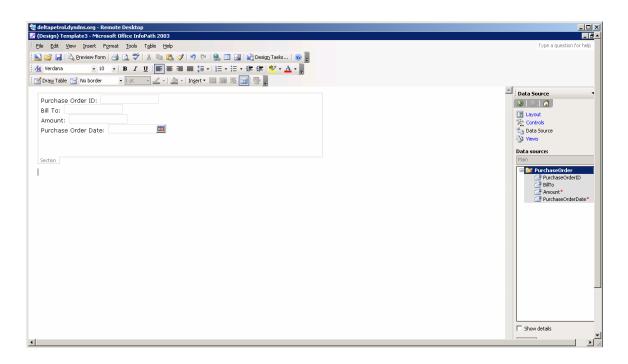


Figure 3.30 Data Source Task Pane.

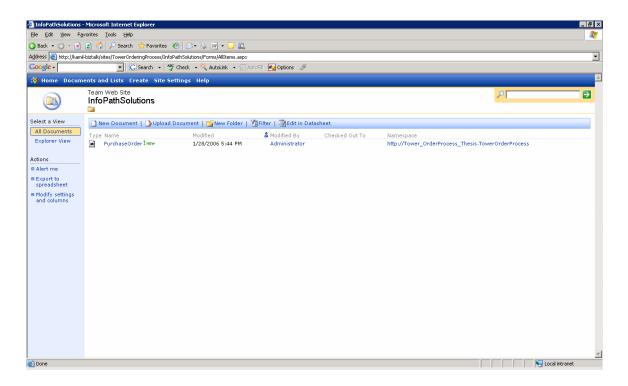


Figure 3.31 Modify SharePoint Document Libraries

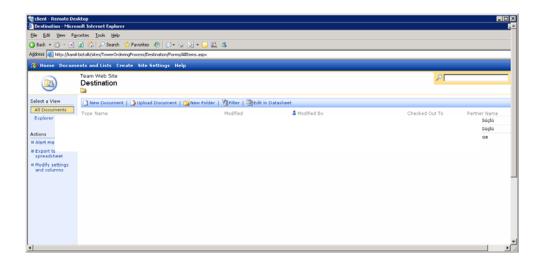


Figure 3.32 Modify the Destination Document Library

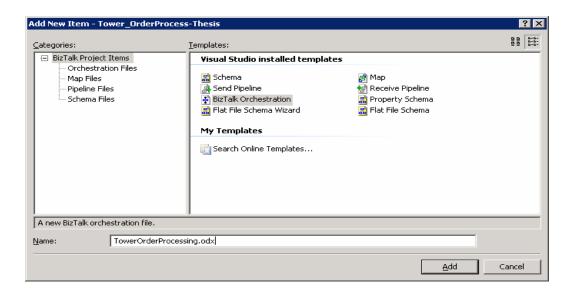


Figure 3.33 Creating the Orchestration

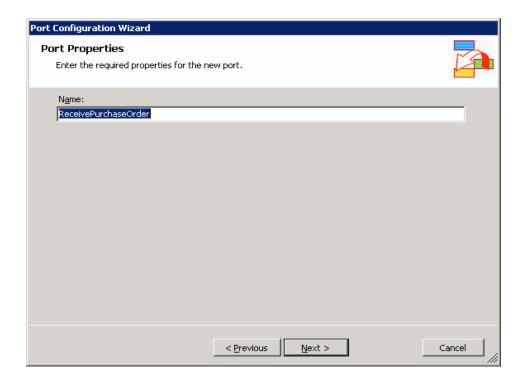


Figure 3.34 Adding Receive Port to the Orchestration

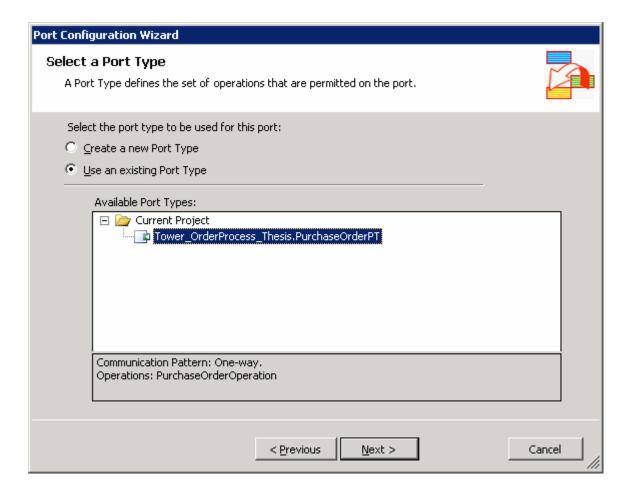


Figure 3.35 Port Binding Screen

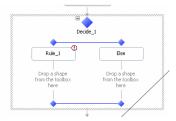


Figure 3.36 Decide Shape

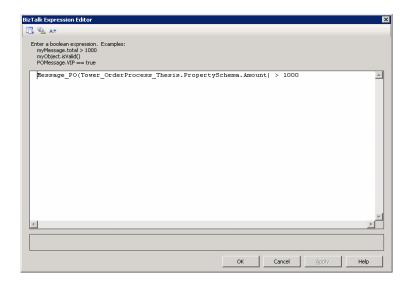
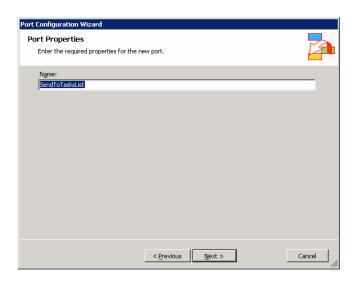


Figure 3.37 Order Process > 1000

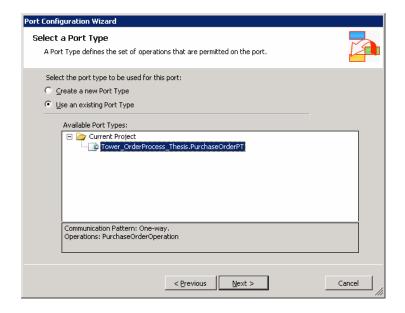


Figure 3.39 Port Types

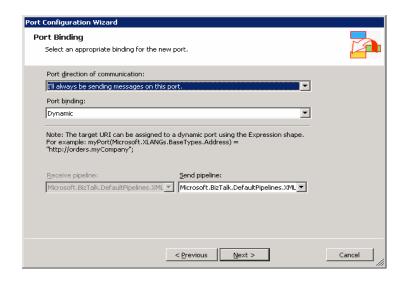


Figure 3.40 Port Binding

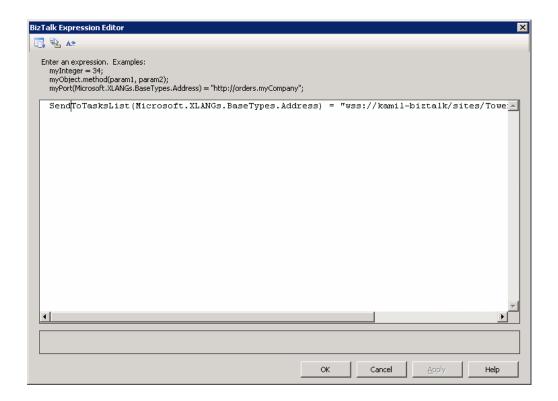


Figure 3.42 Creating a New Expression

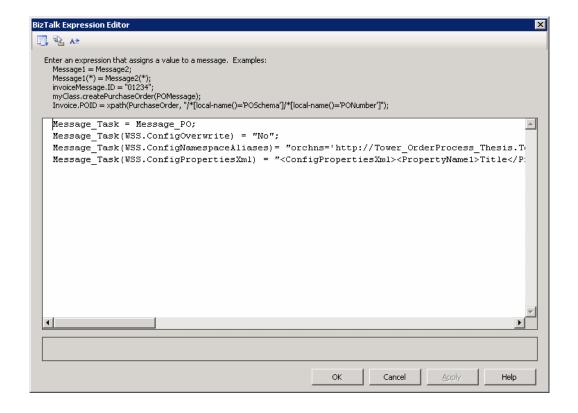

# Sending a Message through the System:

In this procedure you create an InfoPath form and upload it to the Windows SharePoint Services Web site. The Windows SharePoint Services Adapter will take that message, archive it in the Archive document library, and then send it to the Destination document library. During the processing of this message, Windows SharePoint Services context properties will be accessed that help determine the destination.

*Create an InfoPath Form to send through the system:* 

- 1. Open a web browser and navigate to http://kamil-biztalk/sites/ TowerOrderingProcess
- 2. On the left hand side, under Documents, click *InfoPathSolutions*.
- 3. Click the *PurchaseOrder* file, and then click **Open**. InfoPath will load the form.
- 4. In the **Purchase Order ID** field, type 1002.
- 5. In the **Bill To** field, type *Kamil Güçlü*.
- 6. In the **Amount** field, type 1500.
- 7. In the **Purchase Order Date** field, type 2/2/2006.
- 8. Click Save.
- 9. In the **Save As** dialog box, type http://kamil-biztalk/sites/ TowerOrderingProcesss/Source in the **file name** field, and then hit Enter.

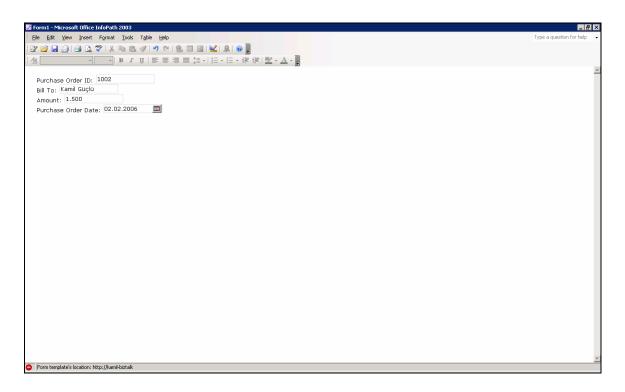


Figure 3.44 Create an InfoPath Form to Send through the System.

- 10. Type PurchaseOrder2.xml in the file name field, and then click Save.
- 11. Close Microsoft Office InfoPath 2003.
- 12. In the web browser, on the top navigation bar, click **Documents and Lists**.

- 13. Under **Document Libraries**, click **Destination**.
- 14. In the Destination Document Library, you will now see your message listed in this library. You will also find a copy archived in the Archive Document Library.
- 15. Click Home.
- 16. Under Lists, click Tasks.
- 17. In the Tasks list you will see the newly created approval task.

### Note:

In the Destination Document Library, the file name column should contain the value of the PurchaseOrderID field and the Partner Name column should contain the value of the BillTo field. Since the amount of the purchase order was over \$1,000.00, the task was created.

#### 4 CONCLUSION AND RECOMMENDATIONS FOR FUTURE WORK

Business Process Management (BPM) is becoming a very important topic for organizations that are spending great amounts of time, resources and money to automate business procedures to become more efficient in today's global market. As BPM is growing more and more popular in today's world, more and more businesses that desire to streamline processes and save money are adopting BPM in their future strategies.

The Infrastructure defined when followed with the proper Methodology defined in this thesis makes the arcane science of enterprise application integration a thing of the past. But this road that lies ahead will not be easy for the implementers.

This thesis associate with BizTalk Server 2006 Installation Guide and by expanding it, explains how BPM implementers should behave and decide when creating BPM environments. The Methodology provided in this thesis brings guidance which creates a standard view and a common platform into the world of implementing BPM to get the benefits of the single platform for business process management. End-to-end process management is very important to managers but without the proper vision and ideology BPM projects can fail miserably.

This is why it is important that we bring standards to this growing technology that is becoming a necessity with the current needs of businesses by creating standards in infrastructure and methodology for business process management.

Recommendations for future work would be to integrate Artificial Intelligence with BPM which would create the thinking Information Worker.

APPENDIX A ABBREVIATIONS

**ACID:** Atomicity, Consistency, Isolation, and Durability.

**BAM:** Business Activity Monitoring

**BizTalk Orchestration Designer:** A design tool used to create drawings that describe long-running, loosely coupled, executable business processes. The XLANG schedule drawing is compiled into an XLANG schedule that is used to execute the automated business process.

**BPEL:** Business Process Execution Language

**BPM:** Business Process Management

**BPMS:** Business Process Management System

**DC:** Domain Controller

**Document Type Definition (DTD):** A standard definition that specifies which elements and attributes might be present in other elements and attributes and that specifies any constraints on their ordering, frequency, and content.

EAI: Enterprise Application Integration

Extensible Stylesheet Language (XSL): A style sheet format for Extensible Markup Language (XML) documents. XSL is used to define the display of XML in the same way that cascading style sheets (CSS) are used to define the display of Hypertext Markup Language (HTML). BizTalk Server uses XSL as the translation language between two specifications.

MOM: Microsoft Operations Manager

MSMQ: Windows Message Queuing

MSMQT: BizTalk Message Queuing Adapter

**OASIS:** Organization for the Advancement of Structured Information Standards.

**PORT:** A port that requires that all necessary information be provided for an XLANG schedule at design time. The designer who creates the XLANG schedule must know the location to which messages are sent or from which messages are received, as well as the technology chosen to implement the communication action.

**TPI:** Trading Partner Integration
